 During FY2008, SoundExchange represented the interests of all sound recording copyright owners and featured artists on whose behalf it is authorized by the US Copyright Office to collect and distribute royalties paid under the statutory licenses set forth in sections 112 and 114 of title 17 of the United States code. As the sole entity designated by the copyright office to receive payments from services operating under statutory license, SoundExchange represents the interests of all copyright owners and featured artists whose works have been performed. SoundExchange collected royalties from various classes of licensees, including preexisting subscription services, preexisting satellite digital audio radio services, internet -only webcasters, broadcast simulcasters and noncommercial entities. SoundExchange collected royalties from over 1,300 licensees and distributed royalties to over 12,000 sound recording copyright owners and featured artists. SoundExchange also distributed royalties to the independent administrators authorized by statute to distribute royalties to nonfeatured musicians and nonfeatured vocalists.
