INTRODUCTION – AND A TEASER FOR DMN PRO'S UPCOMING MUSIC INDUSTRY LITIGATION TRACKER

One thing the music industry doesn't lack is litigation – or threats of litigation. But what kinds of disputes are behind the steady stream of lawsuits?

DMN Pro zeroed in on that question by analyzing data from its soon-to-be-released Music Industry Litigation Tracker. Comprehensive and filterable, the one-stop database of industry and industry-adjacent suits will feature a variety of case-specific details – from the involved parties and their counsel to assigned judges and court venues.


The Music Industry Litigation Tracker will help to illustrate key music sector trends and help users stay apprised of

the latest actions and follow existing complaints. In an industry that's moving faster than ever, the takeaways, like those attributable to DMN Pro's **funding** and **IP acquisition** trackers, are valuable on multiple levels.

From a legal perspective, here's a look at the industry's litigation landscape and what the future could have in store for the space.

INDUSTRY LITIGATION AT A GLANCE: A PERCENTAGE BREAKDOWN OF CASE TYPES, AUGUST 2024

ACTIVE MUSIC INDUSTRY LITIGATION BY TYPE, AUGUST 2024



The best way to begin an analysis of the industry's litigation makeup is with a percentage-breakdown overview of the issues at the heart of ongoing cases. While legal threats, cease-and-desists, mediations, and contractual discussions abound, when it comes to filed disputes, DMN is currently tracking around 140 complaints as of August 2024.

Though multiple data points jump out, the continued prevalence of infringement suits is telling given the relative lack of massive verdicts against artists and rightsholders themselves. In short, labels and publishers are still finding major success with infringement actions against ISPs and companies, but "Dark Horse" **verdicts** are now few and far between.

Furthermore, a glance at the compiled industry cases underscores the comparative infrequency of infringement complaints filed by artists as opposed to broader rightsholders. The latter group includes the major labels and the publishers that **recently sued** over a dozen NBA teams for infringement.

Additionally, while largescale licensing disputes are (mostly) in the rearview – the recent exception being Universal Music's ugly, since-resolved **disagreement** with TikTok – smaller-scale confrontations are cropping up between government-mandated royalty-collection entities and the likes of Spotify and SiriusXM.

COPYRIGHT INFRINGEMENT ACTIONS TAKE CENTER STAGE – WITH SURPRISINGLY LITTLE PRECEDENT TO SHOW FOR IT

Elaborating on those key ideas, DMN Pro's tracking makes clear just how many of today's legal battles involve infringement. That's not especially surprising at the top level. We've provided detailed updates and analyses about the complaints in our regular coverage, including exclusives <u>about</u> <u>cases</u> that would have otherwise fallen through the media cracks.

Nevertheless, the sheer scope of copyright claims is telling when laid out as a portion of all active litigation. Of the approximately 140 suits we're tracking, about 55% center on the alleged theft of copyright. Another 9.5% or so revolve around patents and trademarks, with a combined total of over 64% of litigation therefore revolving around music IP.

Noteworthy in light of the figures is the relative lack of copyright precedent and significant rulings in recent years. Though the tracked suits are ongoing and may prove important when all is said and done, as of late, copyright litigation has in some ways been defined by questionable merit and minimal overall relevance.

That refers, in part, to the substantial number of infringement actions courts have tossed (or will toss) before trial because the works in question simply don't resemble one another. Even legal battles that culminated with jury verdicts – such as the well-documented "Thinking Out Loud" and "Let's Get It On" infringement action that Ed Sheeran beat in May 2023 – didn't necessarily produce meaningful guidance. After Sheeran topped that case's appeal in September 2023, he was **targeted** by a different appeal yet over the same tracks the following month.

But we aren't entirely without infringement actions that have the potential to establish far-reaching precedent. As covered in our **rundown of noteworthy suits**, the RIAA's complaints against generative AI platforms Suno and Udio have arrived amid increasingly heated debates about the materials on which artificial intelligence is trained and whether the process constitutes fair use.

And a **sweeping suit** filed by reggae rightsholders against an array of defendants could break new ground on precisely which musical elements are protectable under stateside copyright law.

TROUBLE BENEATH THE SURFACE: THE INFLUX OF ROYALTY-COLLECTION LAWSUITS AGAINST MUSIC SERVICES

As noted, DMN's database drives home the surprising number of royaltyrelated actions in an industry that, with the exception of Universal Music's brief TikTok withdrawal, has largely avoided disputes with leading platforms in recent years. Exiting YouTube today would have a dramatically different impact on labels and artists than it did in the past.

With that said, the sphere is hardly free of friction and little-discussed legal actions. Most conspicuously, this includes the Mechanical Licensing Collective's **lawsuit** against Spotify over its bundling reclassifications. But the MLC is also **suing** Pandora, while SoundExchange is litigating against **SiriusXM** and **AccuRadio**, to name some.

In other words, rights- and usage-related disagreements aren't nonexistent in the contemporary music landscape. However, in another interesting shift, actions spearheaded by government-appointed royalty collectors have mainly replaced those launched against established platforms by industry companies themselves. Excepting the National Music Publishers' Association's X **infringement action**, Epidemic Sound's copyright complaint against Meta, and rumblings of a Universal Music v. TikTok suit that never materialized, litigation and public battles against potentially lucrative partners like Roblox, Peloton, and **Twitch** are relatively rare today.

The reality attests to both the potentially sizable rightsholder paydays available under licensing pacts and the evident upside of offering music to customers (and avoiding legal showdowns) for companies operating beyond the core industry.

MUSIC-SPACE LAWSUITS MOVING Forward: What to expect in the Remainder of 2024 and beyond

As seasoned observers are well aware, there's no telling which industry legal battles will erupt or how the cases will play out. At the top of 2024, few (if any) were anticipating the MLC's suit against Spotify. (On the other hand, the <u>subscription reclassifications</u> that spurred the action seemingly came as a surprise to the publishing sector.) But we aren't without indications of where things are trending.

First, it can be stated with confidence that big-name companies and brands are on notice when it comes to infringement claims. For example, Sony Music is litigating against both **OFRA Cosmetics** and **Marriott International** over the alleged unauthorized use of music in social media promo videos. For several reasons (chief among them the case type's success rate), similar complaints are presumably forthcoming from throughout the industry.

Next, Al-focused actions could make genuine progress in the new year. Though some early training-related cases are likewise ongoing, newer RIAA-powered suits against **Suno and Udio** (as well as one pitting music publishers **against Anthropic**) appear positioned to bring clarity to urgent and heretofore unexplored questions. In the music world, the most important of those questions involves whether training AI models on protected content is legal under U.S. copyright law.

Lastly, we could witness trials in noteworthy, long-running cases next year – like Epidemic Sound's copyright action against Meta. Filed back in July 2022, the suit is heating up, with Meta now facing an order to reveal the terms of its licensing deals with the major labels.
